# Norfolk Town Board Organizational Meeting

February 8, 2024 DRAFT

The Norfolk Town Board held its regular monthly meeting on Thursday, February 8, 2024 at 6:00 PM at the Norfolk Town Hall.

Present: Supervisor Charles Pernice, Deputy Supervisor Eric Molnar, Councilwoman Jean Gang, Councilman Richard Bump and Councilman Martin Blair Sr.

#### PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was said by all present.

#### **CALL MEETING TO ORDER**

Supervisor Pernice called the meeting to order.

## APPROVAL OF MINUTES

The minutes of the 1/11/2024 Town Board Meeting were reviewed and approved as submitted with a motion by Councilman Bump and Councilwoman Gang. All in Favor – Carried

#### SUPERVISOR'S UPDATE

- ➤ Supervisor Pernice noted that our current water / sewer hook up fees of \$300 and \$200 respectively, were no longer adequate to cover our costs. There was agreement to take a closer look at this and follow up at the next meeting.
- ➤ Supervisor Pernice also noted that periodically we have issues with tree roots clogging up sewer lines that are the Town's responsibility to repair. There is a piece of equipment (cutter) that we could purchase so that we can take care of these problems without having to hire it out. Quote \$3.605.00
  - Decision to purchase this piece of equipment (referenced above) for sewer line clean out was approved with a motion by Deputy Supervisor Molnar and Councilman Bump. All in Favor - Carried

- ➤ Supervisor Pernice also noted that we have had to borrow a pump from the Village of Norwood to take care of work at the sewer plant on multiple occasions. Approximate cost \$35,000.00. There was discussion.
  - Decision to purchase this piece of equipment (referenced above) was approved with a motion by Councilwoman Gang and Councilman Blair. All in Favor - Carried

  - The broken sewer plant hydrant shaft is being fixed over at Northern Machining (Ted Ashley)

- Pumped clarifier #2 out and it's back up and running.
- Brake job done on Truck #4.
- Sander chain broke on Truck #6. Fixed by Danny in house. Back up and running.
- New EGR valve put in truck #9 for 4<sup>th</sup> time. Danny did this too. Saved
  \$4,000 by doing it in house.
- Chain starter motor on pump #1 pumping station. New starter motor installed by Pete and Danny.
- Sewer issue under Clinton Street (tree roots) needs to be cut out.
- The highway crew worked all night and then some, during the freezing rain we had recently, to make sure the roads were kept safe.
