Supervisor Pernice noted that in follow up to the request by property owners of 5 Sunset Drive: Currently there are no existing or planned homes on Sunset Drive. Estimated cost to extend the water main to the property in question (5 Sunset Drive) is \$86,000. Estimated cost to extend the water main to all of Sunset Drive is \sim \$300,000 – \$350,000. There are no plans to extend the water main at this time. However, if the property owners wish to put a camper on the property, we will run a 2" line off the existing main for them.
