# APPROVAL OF MINUTES

# REPORTS

\*Monthly Police Report: The report of the Police Department was reviewed and approved as submitted with a motion by Councilwoman Gang and Councilman Paige. All in Favor – Carried

\*Monthly Code Enforcement Report: The monthly report of CEO Leonard Halpern was reviewed and approved as submitted with a motion by Councilman Purvis and Councilman Paige. All in Favor – Carried Code Enforcement Officer Leonard Halpern noted a special thank you to the Norfolk Fire Department for their assistance to the homeowners on SH 310 who experienced extensive damage to their home as the result of a gas explosion. Deputy Supervisor Rick Bump gave an overview of the circumstances. Luckily no one was injured.

\*Monthly Town Clerk Report: The monthly report of Town Clerk Jill Molnar was reviewed and approved as submitted with a motion by Councilman Paige and Deputy Supervisor Bump. All in Favor – Carried

\*Monthly Dog Control Report: The monthly report of Dog Control Officer James McConkey was reviewed and approved as submitted with a motion by Councilwoman Gang and Councilman Purvis. All in Favor – Carried

\*Monthly Court Report: The monthly report of the Norfolk Justice Court for January & February was reviewed and approved as submitted with a motion by Councilman Paige and Deputy Supervisor Bump. All in Favor – Carried

\*Annual Norfolk Hepburn Library report was reviewed and accepted with a motion by Councilman Purvis and Councilman Paige. All in Favor - Carried

\*Verbal Highway Report: Highway Superintendent Peter Darabon noted the following:

- Acknowledged that Sober Street is in terrible condition and that it's a good thing is going to be paved this summer.
- There was a water service line break repaired in front of the Post Office in Raymondville.
- Several culverts have been repaired.
- Several areas of roads have been patched.
- Due to the severe increases in fuel costs the town will be getting additional funds from the county.
- Supervisor Pernice noted special acknowledgment to Highway Superintendent Pete Darabon on the excellent job he's doing with managing the towns' resources through this winter season. One specific example being that we've had more bad weather than in recent years such that other surrounding towns have run out of sand. We still have a good supply left.

# PUBLIC COMMENTS

County Legislator John Burke was in attendance.

- He noted that the county is getting \$21M in ARPA (American Rescue Plan Act) funds. General comments from the attendees were that those funds should be used by the county for highway/paving and bridges.
- He also noted that the county received \$1.6M from the Opioid Settlement. There was discussion about how hard the county and our communities have been effected. Many lives lost due to overdoses. There is a great need for local treatment options. The county is moving forward with plans to bring a methadone clinic to the Human Services Center in Canton.

Alan Sweet requested the Town provide assistance in helping him resolve (clean up) the property he owns at 80 Grantville Rd. by having the town formally condemn the structure. Code Enforcement Officer Leonard Halpern noted that he could declare it unsafe. When asked why he didn't evict the tenant Alan stated that he didn't want to incur the cost (\$2,500) of doing that. Supervisor Pernice noted that he would seek council from the town's attorney to see what options may be available.

\*Resignation of Norfolk Police Officer Brandon Tavernia was accepted with a motion by Councilwoman Gang and Councilman Paige. All in Favor – Carried

• Supervisor Pernice noted that he's going to work for the Tribal Police and they would be buying some of the equipment (~\$4,000) that we'd purchased for him.

\*Second Notice Fee of \$2.00 per parcel for unpaid taxes was approved with a motion by Councilwoman Gang and Deputy Supervisor Bump. AIF - Carried

\*Time Warner Cable Adjustments to tax bills: Time Warner Cable pays the Town of Norfolk franchise fees annually. So each year they submit their payments of taxes excluding the Town of Norfolk lines. (bill #44 \$86.45 & bill #2591 \$669.67) This year's total adjustment is \$756.12 and was approved with a motion by Supervisor Pernice and Deputy Supervisor Bump. All in Favor – Carried

\*Resolution #7 Loan Resolution Authorizing and Providing for a Portion of the cost of the 2023 Plow Truck was approved with a motion by Councilman Paige and Councilman Purvis. All in Favor – Carried
