## **PUBLIC COMMENTS**

Travis Villnave requested the Town support his volunteer efforts to establish a skating rink in the Raymondville Park. Supervisor Pernice and Highway Superintendent Peter Darabon are willing ..... noting that it hasn't been cold enough in the past few seasons to freeze but if weather conditions support it this upcoming year they agreed to assist.

There was discussion regarding use of Memorial Garden Park on W Main Street by the Norfolk Concert Series and Hazel's Ice Cream.

The problem of feral cats was brought up by Lynda Paige (specifically up at the Elm Circle park). Supervisor Pernice noted that the Town currently has a Dog Control Officer who only deals with dog issues. Travis Villnave noted that he has a contact with a local cat rescue organization and would share the information. The issue of feral cats is occurring in other areas around town as well.
